Prohibition every day, from 7h00 to 21h00

The borders of the zone Center are as follows: Opalchenska str. – Slivnitza bld. – Gen. Danail Nikolaev bld. – Evlogui Gueorguiev bld. – Bulgaria bld. – Pencho Slaveikov bld. – Gen. Totleben bld. – Gen. Skobelev bld. – Opalcheska str.

(N.B.: The zone do not include the streets mentioned above, but only the area bordered by these streets)

Vehicles concerned buses and coaches with more than 22 passengers' seats ¹⁾

Prohibition every day, from 7h00 to 21h00

Area concerned Sofia City – Centre

Vehicles concerned trucks and combined vehicles of over 15t MPW ¹⁾

Prohibition permanent in Zone 1

Area concerned **Sofia City – Zone 1**

1) In special cases an exemption permit to run in the restricted areas in Sofia can be obtained after handing in an application with copies of the vehicle registration certificate, of the licence and of the document, proving the need to entry the restricted area/s, to the Transport Department of Sofia Municipality, 17, Budapesta str., 6th floor, Sofia, BG-1000. The following data must be filled in the application: company name, address and telephone; area of movement; make (trade name of manufacturer), registration plate and gross weight of the vehicle. The application can be handed in only by a local entity that is why we advise your hauliers to ask their clients in Sofia (consignees, forwarding companies) to obtain the permit for them. The Bulgarian company has to present a certificate for absence of obligations.

Driving Restrictions, Goods Transport Turkey

1. GENERAL DRIVING RESTRICTIONS

There are no driving restrictions on goods vehicles at weekends or on public holidays in Turkey.

2. SPECIAL LOCAL TRAFFIC RESTRICTIONS

Previous driving restrictions on bridges in Istanbul have been removed by opening the third bridge, Yavuz Sultan Selim in Istanbul, connecting Europe to Asia.

Heavy goods vehicles and buses have to use the Yavuz Sultan Selim bridge without any driving restrictions and are forbidden to use the other 2 bridges in Istanbul.

Vehicles that are carrying dangerous goods can pass the Yavuz Sultan Selim bridge under definite conditions and detailed information can be received by contacting Bridge Authorities.

Driving Restrictions, Goods Transport 2020 United Kingdom

There are no driving restrictions at weekends or on public holidays in the United Kingdom.

Local restrictions

Vehicles concerned	trucks exceeding 18t total permissible weight
Prohibition	during the week, from 21h00 to 07h00; at weekends, from 13h00 on Saturday to 07h00 on Monday
Area	Greater London - all roads, except motorways and certain major roads, in those areas administered by the London Boroughs' Transport Scheme (applies to all 33 London boroughs)
Exceptions	<ul style="list-style-type: none">•vehicles operating under special authorisation because they are carrying an abnormal indivisible load;•vehicles "whose load is required for the purposes of dealing with any emergency affecting the safety of persons or property".

Transport operators must apply for exemption permits which are supplied free of charge by the

In certain circumstances short-term permits are available at short notice for single journeys. Operators should note, however, that permit conditions impose special routing requirements on drivers. For more detailed information, operators should contact the above office.
